# STIPULATION OF DISMISSAL WITH PREJUDICE PURSUANT TO NEW MEXICO SETTLEMENT AGREEMENT

The undersigned Parties (the "Parties") have settled the above-referenced litigation against Defendants Walgreen Co., Walgreen Eastern Co., Inc., and Walgreens Boots Alliance, Inc. (together, "Walgreen") pursuant to the Walgreen New Mexico *Settlement Agreement and Full Release of Claims*, executed on March 7, 2023, attached here as Appendix B, in which Plaintiffs, the New Mexico subdivisions listed in Appendix C have elected to participate.<sup>2</sup> Pursuant to Federal Rule of Civil Procedure 41(a)(1)(A)(ii), Plaintiffs and Walgreen agree that all claims of Plaintiffs in the actions identified in Appendix C against Walgreen or any other Released Entity, including any entity identified in Appendix A, are dismissed with prejudice, with each party to bear its own costs.
